1. All items are sold as is, where is, with all faults. There are no warranties or representations of merchantability, of fitness, nor any other kind, express or implied. All items are available for your examination prior to bidding. Your bidding will signify that you have examined the items as fully as you desire, or that you have chosen not to examine them. Written and oral descriptions are our opinions and should in no way be construed as a guarantee of any kind as to age, condition, materials or any other feature of items being sold. Our goal is to provide prospective bidders with accurate and detailed information. We recommend prospective bidders examine all items in which they have an interest. If you require absolute certainty in all areas of authenticity, and the results of your evaluation leave uncertainty in your mind, we recommend you not bid on the item in question. We do not give refunds. All sales are final. No statement written or oral made by the auctioneer shall be deemed a warranty or assumption of liability by Murrell's Auction Company or by and seller represented by Murrell's Auction Company.

2. Once we declare that an item is sold, we cannot reopen the bidding. It is the bidder's responsibility to get our attention prior to our saying "sold". We reserve the right to reject any bids deemed inappropriate. If an item is withdrawn from the auction it will be offered again only at the auctioneer's discretion.

3. Payment must be made by cash, approved check, Paypal, or Mastercard and Visa credit cards. We reserve the right to require bank checks for large purchases.

4. Payment for all purchases is expected at time of purchase. Payment for successful absentee bids is required within 3 business days of the auction. Your signature on the ABSENTEE BID FORM constitutes permission to charge successful bids to credit cards if payment is not received within three (3) business days of the auction.

5. We are pleased to offer absentee bidding for prospective bidders who cannot be present at the auction. Please complete the ABSENTEE BID form. Absentee bids left with us are executed competitively and confidentially. In the case of identical bids left with us, the bid received first will prevail. The deadline for absentee bids is 6:00 PM prior to the date of the auction. We make every effort to honor all absentee bids, but we are not liable for any losses incurred as a result of failure to execute absentee bids. Submission of absentee bids does not imply an extension of credit.

6. Purchaser agrees that packing and shipping is done at the purchaser's risk and that the purchaser will pay in advance all packing expense, materials, carrier fees and insurance charges. At our discretion, items will either be packed by and agent such as UPS store, or Murrell's Auction Company. Please allow two weeks for shipping after payment is received. Shipment of large items is the responsibility of the purchaser. Murrell's Auction Company will have no liability for any loss or damage to shipped items.

7. All purchases are subject to 5% South Carolina sales tax, and 1% local option sales tax, unless the South Carolina Resale Certificate form is fully completed and received prior to time of purchase. Resale tax numbers from other states are accepted.

8. Bidding on an item indicates your understanding and acceptance of these Terms of Sale. If purchaser breaches any of these Terms of Sale, including the obligation to pay for purchases items, Murrell's Auction Company may seek all remedies under the law including canceling the sale and reoffering the property without reserve at the risk of the defaulting purchaser.

9. A buyer's premium of 10% will be applied to the hammer price of all items.

10. Bidders in attendance at the auction must move their purchases the day of sale.
